In the event it becomes necessary to incur collection costs or institute suit to collect any amount due underthis Agreement or any portion thereof, the Company Applicant promises to pay such additional collection costs, charges and expenses including attorneys fees pursuant to this contract or CCP 1717.5 whichever is greater.

For good and valuable consideration which is hereby acknowledged, which includes, but is not limited to Tapia selling goods and merchandise to Company Applicant, I/We the undersigned are signing this Agreement in two capacities, both for the Company Applicant and as individuals. I/We, the undersigned, in our individual personal capacities, by this Agreement do expressly personally, unconditionally, jointly, severally, irrevocably and continually personally guarante to pay the indebtedness of the Company Applicant to Tapia for all past and future goods and merchandise purchased by the Company Applicant.
